REVENUE BY CATEGORY

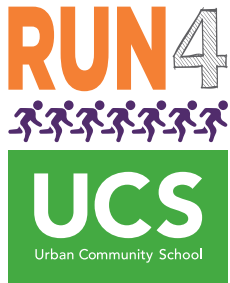

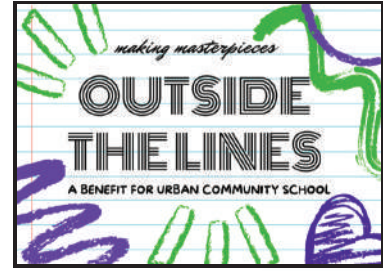

CONVERT YOUR TAX DOLLARS INTO KAZEL SCHOLARSHIP DOLLARS

Through the Ohio Association of Independent Schools Scholarship Granting Organization (OAIS SGO), Ohio taxpayers can receive a non-refundable tax credit of up to \$750 (individual) or \$1,500 (married couples filing jointly) on their Ohio income tax return for monetary donations made to an eligible SGO. As a result, Urban Community School established the **Kazel Scholarship**. Donations designated to UCS, made through the OAIS SGO, will be directed toward the **Kazel Scholarship**. With 80% of our students receiving tuition assistance, access to scholarships is critical.

STEP 3

You will receive an immediate electronic confirmation of your gift for your records from OAIS. Claim your tax credit on your 2023 Ohio tax form.

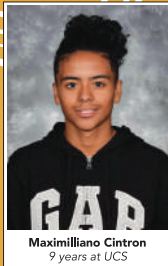

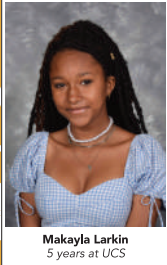

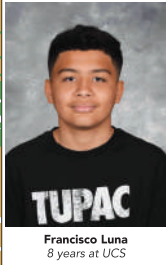

These outstanding individuals, Terrence (Terry) McCafferty '18, and Selina Hokello '19, are currently enrolled at Harvard University, a testament to their hard work, determination, and the excellent foundation they received both at Urban Community School and their respective high schools, Saint Ignatius High School and Laurel School.

At UCS, we take great pride in our commitment to nurturing the potential within each of our students. It's heartwarming to see how much of an impact our school has had on both Terry and Selina, helping to shape them into the future leaders they are destined to become.

The success stories of Terry and Selina is not just a reflection of their own dedication but also a testament to the unwavering support and dedication of our faculty and staff. Our teachers, mentors, and volunteers go above and beyond to ensure that every student receives the academic, physical, social, emotional, and spiritual support they need to thrive. Terry stated, "It would be hard to overstate how much I owe to the nine years of education I received at Urban. UCS helped instill in me a desire to be engaged in issues facing our society, inspired by the mission of the Ursuline Sisters and the lives of people like Sister Dorothy Kazel, OSU." While attending UCS, Selina learned how to interact with different people. "The school is filled with many students who come from a variety of backgrounds and that helped me with developing communication skills and building a foundation of understanding others and how their experiences may impact their actions." Because of this, Selina started an initiative at Laurel to change their own honor code. She wanted to include language that was applicable to the individual so they could understand their rights and responsibilities as members of their community.

Change can be hard at times and it took both Terry and Selina a bit to transition from UCS to high school. However, they were both well-prepared to work hard academically and not be afraid to ask for help when they needed it. Having a supportive and welcoming environment with familiar faces made such a difference. Terry mentioned that "running on the cross country team since 3rd grade gave me a pretty solid group of guys early on, some of whom ended up becoming my closest friends at Ignatius." The 8th grade Graduation Outcomes Project (GOP) helped Selina "feel prepared to take on such a demanding school load given how in-depth the GOP had to be." She also mentioned how strong of a community she had at Laurel, even when her 9th grade year was cut short due to the pandemic.

Both Terry and Selina were eager to be fully immersed in their respective high schools. Terry helped run the student newspaper (The Eye) and Model United Nations team, along with various service opportunities such as With Friends of L'Arche and The Labre Ministry. Outside of school, Terry volunteered in the local community organizing at Northwest Neighborhoods CDC (formerly Detroit Shoreway CDO) and politics, including with Councilwoman Jenny Spencer's 2021 reelection campaign in Ward 15. Selina, on the other hand, had an interest in the arts and was involved in theater both in and outside of school. She volunteered, helped choreograph, and performed in "Rise" at Near West Theatre, and was the dance captain for Laurel School. Selina also took part in Laurel's Capstone Program and co-led a board game club at school.

Moving on from high school to college can be another big and sometimes scary transition. You move away from family and friends. Your workload can dramatically increase. But there are also so many positives to this change. It is a chance to create your own identity, make new friends, try new things, and embrace all the world has to offer. Terry and Selina chose to welcome this challenge.

At Harvard, Terry is currently studying social studies, combining both theory and research to examine the pressing social, political, and economic problems facing modern societies. He is very excited as "it is considered one of the more rigorous concentrations at Harvard because of its rigorous 8-student tutorials and 80-120-page thesis requirement." After graduation, Terry would like to do some form of service, whether Peace Corps or the Jesuit Volunteer Corps, and then go back to school for a master's degree in public policy, public administration, or law.

Selina is excited to experience all that Harvard has to offer. She is hoping to study chemistry but is open to seeing what else the STEM field has to offer. Once she completes her college degree, she may go into research but plans to take things one step at a time.

As we celebrate the remarkable journeys of Terry and Selina, let us remember that their success is a reflection of the values and opportunities provided by Urban Community School. We are deeply proud of their accomplishments and look forward to seeing the incredible contributions they will make to our world. Congratulations, Terry and Selina, on this incredible achievement!
